




RELATIVE INTENSITY vs. WAVELENGTH




SPATIAL DISTRIBUTION









Forward Current Derating Curve





REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS




Notes




REEL DIMENSION (units: mm)
