





Figure 1 Typical Forward Characteristics




Instantaneous Forward Current - Amperes*versus* Instantaneous Forward Voltage - Volts

Junction Capacitance




Junction Capacitance - pF*versus* Reverse Voltage - Volts

Peak Forward Surge Current - Amperes*versus* Number Of Cycles At 60Hz - Cycles



