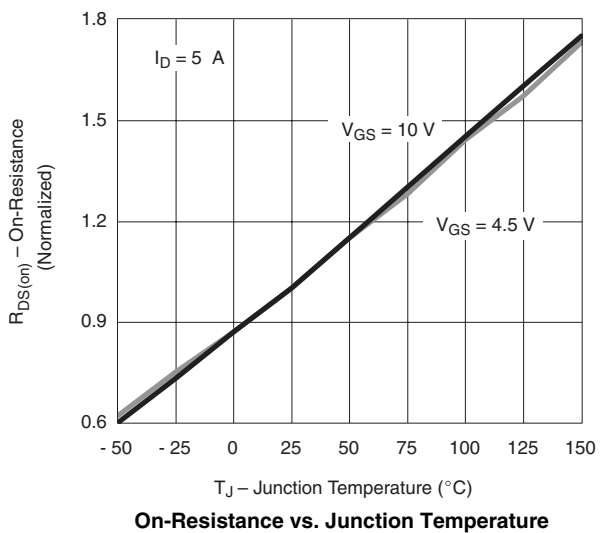
**On-Resistance vs. Drain Current and Gate Voltage**

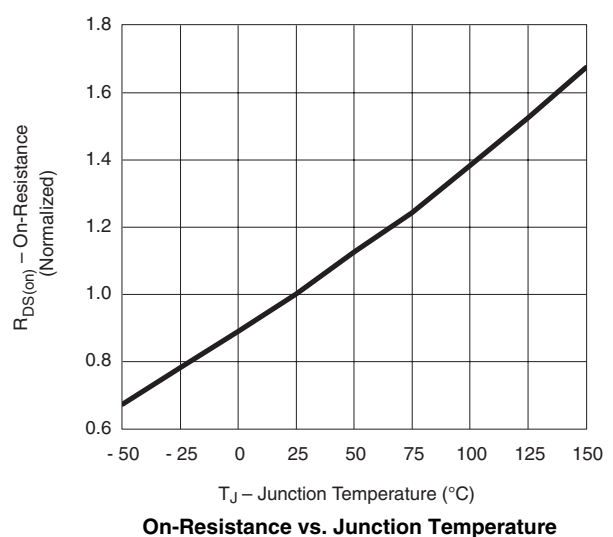
**On-Resistance vs. Drain Current and Gate Voltage**

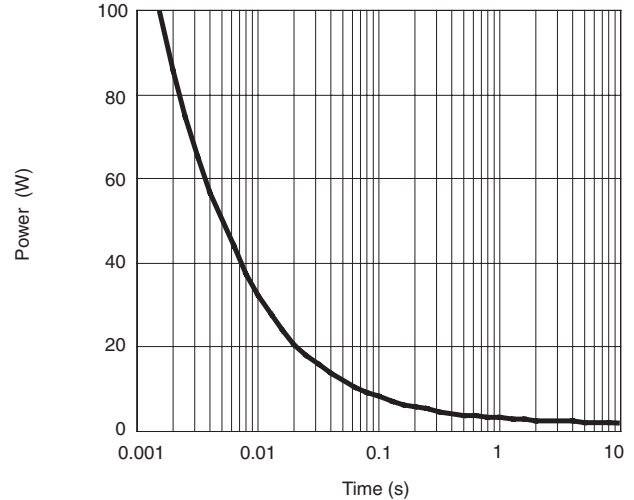
**Source-Drain Diode Forward Voltage**



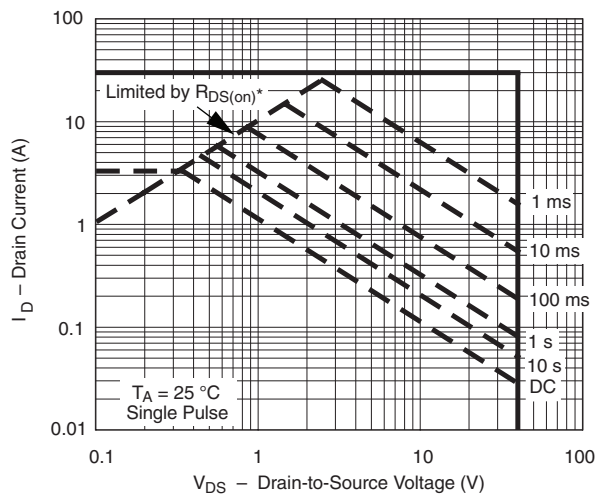

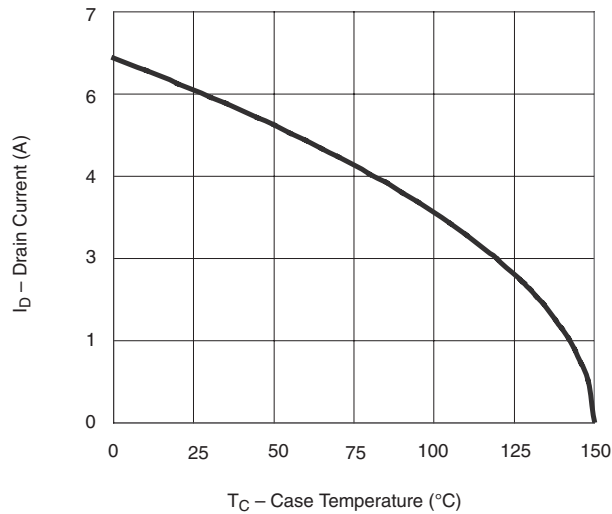
**Single Pulse Power vs. Junction-to-Ambient**



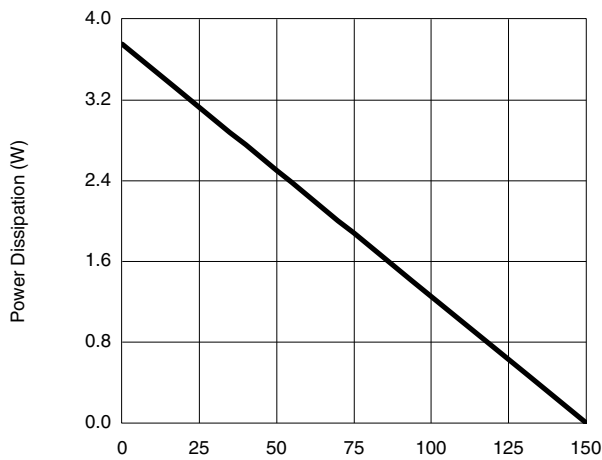
