
SN54ALS133 ... FK PACKAGE (TOP VIEW)



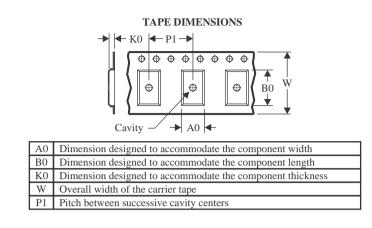
