





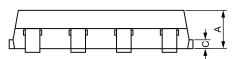




Topside view
